- 9- The pictures are numbered and written Figure 1:, Figure 2:, ... and the title is at the bottom of the image in the middle
- 10-The references are numbered according to the order in which they are used by research
- 11-When using or referring to any part of a reference, the reference number in the paragraph is written like this [1] and this means reference No. 1
